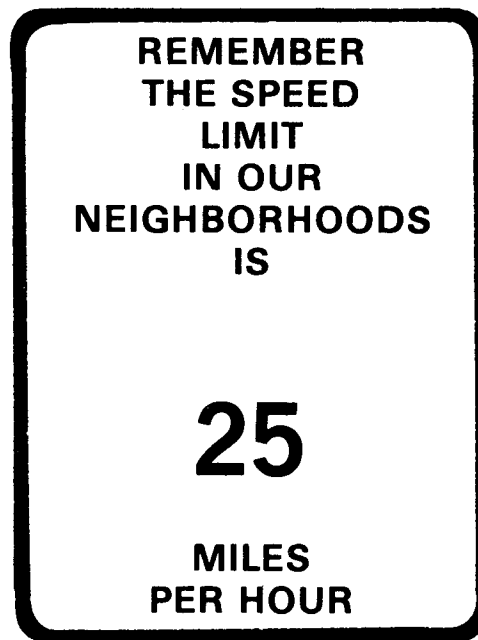

Word has been received from the V.E.P. attorney handling the furnace suit, Charles Kilian, that the suit has been settled. The original court date was set for December 10, 1975, but a verbal settlement was reached on December 5, 1975. The delay since that date was required for signatures on the documents and related matters.

The proposed settlement is to be heard in Superior Court for approval during April, and a complete text of the settlement is to be distributed to all Vistapark homeowners once it becomes available.


