VEP's September Meeting

On September 25th, to a "standing-room only" crowd, President Marilyn Rodgers thanked everyone for coming and briefly reviewed the agenda which included three presentations. Prior to introducing the first speaker, she also introduced Councilmember Nancy Pyle, who was in attendance. The first speaker, Lynn Rogers, Project Manager for San Jose City Cultural Affairs – Public Art Program, provided an overview and status of the Vista Park Gates project. The project is on track for completion by the end of the year. Ms. Rogers reinforced the request from artist/designer/builder Bill Gould for input/feedback from community members on words and symbols that reflect the community's values as well as those of historical significance. Some of these words and symbols will be incorporated into the gates. Participants were encouraged to fill out the questionnaire included in the September VEP Newsletter.

Members asked several questions, and voiced interest and enthusiasm for the gates. One member voiced significant concern regarding the maintenance of the gates – with specific questions as to how damage, i.e. graffiti, would be managed. Ms. Rogers stated that the city has not had problems anywhere with public art projects being damaged and/or targeted with graffiti.

Nancy Pyle spoke in support of the Vista Park Gate project, and stated she looks forward to its completion and dedication. Nancy then acknowledged Dave Fadness for his dedication and many, many hours of volunteer activities. She presented Dave with a plaque from the San Jose Parks and Recreation Department as an "outstanding volunteer", and thanked him specifically for his work caring for and maintaining Vista Park.

James Reber, Executive Director of San Jose City Parks Foundation provided a brief presentation on the Foundation, the partnership between VEP and the Foundation, and the process for VEP members and friends to donate to the Parks Foundation. As a result of the \$1,000.00 donation VEP previously made to the Parks Foundation, Mr. Reber announced that VEP would be a "lifetime member" of the Foundation. Mr. Reber provided a sheet with directions as to how to donate online to the Foundation. Donations can be made to the **VEP Parks Fund**, by going

online to sanjoseparks.org. (50% of all donations to SJPF through VEP will go directly to VEP) All donations are tax-deductible.

The third, and highly anticipated presentation, was done by VEP member Don Ferguson. Don provided an overview of types and costs of video cameras that homeowners can purchase and easily install themselves to monitor and protect their homes, yards, and vehicles. Mr. Ferguson has had several years of personal experience in monitoring his own home and yard. Attendees asked several questions. Interest was particularly high in this information with the recent spike in vehicle break-ins and thefts on several streets/neighborhoods within the VEP area.

Ms. Rodgers provided additional brief information on websites that members can use to monitor illegal activity in the VEP area, as well as contact information for those that are interested in initiating a Neighborhood Watch program for their street.

VEP 2012-2013 Goals and Objectives were approved by the membership. Approval of the annual budget was deferred until the October meeting.

The next meeting, October 23rd will be an Election Forum – plan to attend!


**Gunderson High School

Fall Fundamentals

What! You don't have a compost? still receptacle or pile You can learn how to compost yard waste and food scraps, and get a schedule of free how-to composting classes through the Master Composters program. Just call 299-4147.



I routinely throw grapefruit and orange peelings, coffee grounds, onion tops, wilted greens, banana peels, apple cores, carrot peelings, over-ripe fruit, radish tops, celery tops, and trimmings from most meal preparations into a plastic corner box that sits in our sink. That gets carried to the compost in the yard, which is no more than 18-in. square and 2-ft tall with a lid. You can get attractive compost boxes from Orchards. Give it some thought!

Yes, it's time to get the ladders out and peer into the rain gutters. There, you'll find stray tennis balls, toys, and worst of all, a bunch of rotting leaves. Not only will they rust out the gutters, but render the downspouts useless. So plan to get up there on a sunny Saturday and clear them out.

The leaves that fall on the ground can be tossed into the compost pile, too. Or you can use the lazy gardener's method by raking them into garden beds and use them to cover exposed soil. The leaves will break down over the winter and turn into rich garden humus by spring.

Cool-season vegetables to plant included broccoli, cabbage, cauliflower, peas, radishes, green onions, beets and lettuce grapefruit

The National Gardening Association web site, www.garden.org is full of general information for gardeners. One of its most useful features is a localized report. There are also how-to basics, on-line courses, a horticultural dictionary and plant name finder, events calendar, message board, seed swap and links to a children's gardening site. You can search the site's library for articles. Plant spring-flowering bulbs, including daffodils, tulips, hyacinths and crocus now.

If the recent heat wave sizzled your bougainvillea, don't over-react and take it out. The branches and roots are still healthy and will have new growth, more leaves, and dazzling flowers next spring.

Rose Lovers Take Note

Barbara Milo Ohrbach's 16th book on roses, "Roses for the Scented Room: Beautiful Ideas for Entertaining, Gift-Giving and the Home" (Clarkson Potter, \$25) is now available. This lavishly photographed book covers everything from the history of the rose to selecting the best varieties and decorating with roses.



Among her helpful suggestions in buying, gathering, conditioning and arranging roses include: Pick roses from the garden in the early morning when their scent is strongest; revive drooping roses by inserting a straight pin in the stem to perk up droopy rose heads.

Interesting recipes include rose-petal vinegar, jasmine rose tea, rose cuticle cream and rose-petal splash and fabric wash. There is also a source list for books, suppliers, catalogs, organizations and associations.

October 20th – New Phone Dialing Requirement

Reminder - starting October 20th a new area code will be implemented - 669, will join the current 408 area code. As of Oct 20th both 408 and 669 area code telephone numbers – when calling from a landline phone will be **required to dial 1 + area code + telephone number**. To complete calls from a mobile or cellular phone, callers **may dial either 1 + area code + telephone number, or...just area code + telephone number.** This process will be mandatory beginning October 20th.

Pie For a Year

R-E-M-O-D-E-L These 7 innocent letters follow one another in single file to form one *dangerous* word...*dangerous* to a marriage, *dangerous* to an ego, and *dangerous* to a budget.

The beginning of such a project brings **excitement** (can't wait to see how it will look!) and plenty of **energy** (can we start now?) with a side of **confidence** (I know what I'm doing!).

Soon, though, **anxiety** (why is it taking so long?) creeps in along with its traveling companions, **doubt** (not sure this is right...) and **regret** (shouldn't have started this!).

Several days, weeks, or months later, when the remodel is finished, when the marriage survives, the ego is only slightly bruised, and the budget has been thrown out the window, the only emotions left are **satisfaction** (we did it!) and **pride** (how great it looks!).

My husband and I are in the midst of replacing our outdated countertops making pie construction a real challenge. I was thankful to find this simple but delicious pie recipe that required hooking the stove back up, but needed little counter surface to get the job done (TV trays make excellent counter substitutes...temporarily).

Burrito Pie __ Ingredients: 2 lbs. ground beef, 1 onion, chopped, 2 t. minced garlic, 1 (2 oz) can black olives, sliced, 1 (4 oz) can diced green chile peppers, 1 (10 oz) can diced tomatoes with green chile peppers, 1 (16 oz) jar taco sauce, 2 (16 oz) cans refried beans, 12 (8 inch) flour tortillas, 9 oz shredded Colby cheese.

Instructions: In a large skillet over medium heat, sauté the ground beef for 5 minutes. Add the onion and garlic, and sauté for 5 more minutes, or until browned. Drain any excess fat. Mix in the olives, green chile peppers, tomatoes, taco sauce and beans. Stir mixture thoroughly, reduce heat to low, and let simmer 15-20 minutes. Preheat oven to 350 degrees. Spread a thin layer of meat mixture in the bottom of a 4-qt casserole dish. Cover with a tortilla followed by more meat mixture, then a layer of cheese. Repeat tortilla, meat, cheese pattern until all the tortillas are used, topping off with a layer of meat and cheese. Bake for 20-30 minutes, or until cheese is slightly brown and bubbly.

This recipe was submitted on *allrecipes.com* by KATHIMC. I adjusted the recipe to suit my family's tastes (no beans, no olives, and picante sauce rather than taco sauce). Topping each serving with a scoop of quacamole and/or sour cream would be a delicious addition.

Fourth Annual Neighborhood Development Training Conference

This is a story of how three neighborhood residents became enlightened. Bonnie Boucher, Yogendra Singh and Peggy Golden teamed up to attend, (what they thought) was a training conference put on by the new neighborhood social net-working site



Nextdoor.com. These three had all recently joined Nextdoor and had responded to a link on that site that invited them to the conference taking place at San Jose State University. They were very excited as the conference was offering many workshops with titles like, Great Neighborhoods: Everyvoice Engaged, Neighborhood Communication Skills and Tools, Voting Matters in Neighborhoods, Practical Solutions for Public Safety and even Garden to Table: Grow, Harvest, Share.

One of the highlighted draws to this conference was the ability to win a mini CAP (Community Action & Pride) Grant of up to \$450 for your neighborhood. Bonnie was especially keen on this idea. Her mind whirled with all kinds of possibilities for helping her neighborhood (Nextdoor Parkview). Whether it was for clean up, safety or just throwing a neighborhood party and socializing with her neighbors, Bonnie was on board.

Yogendra was interested in finding solutions to keeping the neighborhood safe. Lately the Parkview neighborhood has had several instances of crime, not to mention speeding cars down neighborhood streets, and unsafe street corners.

Nextdoor Parkview was just getting started with about 24 households. Nextdoor is structured like Facebook, but with a little different platform. Members joining have to live within the boundaries on the Nextdoor map. The site is secure and any new member has to "verify" their address. You share as much personal information as you feel comfortable with, then just get to know what's happening in your neighborhood. Like sharing local recommendations, lending, borrowing, maybe selling something. Reporting any suspicious activity, needing a babysitter, advertising a garage sale, or help find a missing

pet. Posts are strictly kept to events or activities that are pertinent to your neighborhood.

So the three of us got up early on Saturday morning armed with a map of SJSU and eager to see what information they could glean from their chosen workshops. A little confusion ensued as they put their heads together and realized that in order to win those prized grants, they may have to be part of an already established community organization. Light bulb goes on!

Somewhere between choosing workshops and reading the material in the stuffed envelopes, it had become quite evident that this whole conference thing was not just about Nextdoor, but was actually the Fourth Annual Conference put on by the United Neighborhoods of Santa Clara County and the Neighborhood Housing Services of Silicon Valley. Another light bulb!

We attended workshops, had lunch and learned a whole lot of things about engaging the community in learning, service and leadership. This annual event strives to strengthen the voices and skills of neighborhood residents in Santa Clara County. All of it works to improve the welfare of neighborhoods. We, along with everyone else who attended this workshop had the opportunity to apply for the mini CAP grant (this was the first time that participants were all coached through the process of applying for a CAP grant as part of the conference).

Two of the three of us were already active VEP members. However we came thinking this was a conference for new Nextdoor members, so we wrote the grant with the idea that we would be focusing on the Parkview area of VEP. Because, this conference was the first one to encourage participation by neighbors involved with Nextdoor, we were a "first", in breaking new ground in applying for a grant. We were, however, (like everyone else who wrote a grant), promised that we would receive the grant (on a contingency basis). We will have an update in a few weeks when the protocol has been worked out.

So, what we learned is that there are many ways to join in the process of being an active member of your neighborhood. VEP as our larger community association, as well as Nextdoor - we're all on the same streets!

VEP makes good things happen!


