## October Meeting Synopsis

The October meeting started with President Rodgers welcoming and introducing former Councilmember Nancy Pyle.

Ms. Pyle had been invited by Councilmember Khamis to participate in the Vista Park Gates dedication and ribbon cutting ceremony in September, due to her involvement in the project. However, at the last moment, she was unable to attend. Subsequently, Ms. Rodgers extended a special invitation for Ms. Pyle to come to the October meeting. Ms. Pyle expressed her appreciation to everyone in VEP, and also her impressions of the Gates. She thought they were quite dramatic with stunning colors. She was also intrigued by the historic words in the gate. Nancy talked about her health emergency during the summer, and how grateful she was for everyone's thoughts and prayers. She now looks and feels very well.

Next, Ms. Rayshelle Brant, from Councilmember Khamis' Office, shared several announcements. One issue was the concern voiced by residents of the Almaden area concerning wild pigs. The pigs are a danger to residents and pets, as well as destructive. They have caused extensive damage to residents' yards and the grounds of the Almaden Country Club. The City Council will be discussing emergency measures that can be taken immediately to resolve this issue. Secondly, the City Council will be discussing the possible location (out of six possible locations) for the City to build a Softball complex for young people to use. Additional information is available in the Councilmember's newsletter and he would appreciate hearing residents views on this issue. Thirdly, the Councilmember, along with AlmadenCares, is sponsoring a teen video competition focused on preventing risky driving behaviors. This competition is open to all high school students in San Jose, with a grand prize of \$5,000.00. The deadline for participation has been extended to January 10<sup>th</sup>. The next speaker, Ray Bramson, with the City Department of Housing, has the new responsibility of coordinating the Homeless Response Team for San Jose. Mr. Bramson gave a brief overview of the rates homelessness in San Jose. Every year, a count of homeless individuals is done. Currently, over 7,000 people are homeless in San Jose. Approximately 20% are families. Families tend to live in their vehicles, because they are very concerned about victimization. The majority of homeless people in San Jose have lived in the city prior to becoming homeless, often as a result of losing a job. Mr. Bramson said the City is just beginning to ramp up the process for assessing homeless encampments. Once the team assesses an encampment, information about possible resources and assistance is offered to the individuals involved. Those that have been unemployed for a few months are currently a priority for assistance. Attendees asked pointed questions and voiced concerns as there are several encampments along Branham Lane. VEP volunteers have requested approval to assist in clearing brush in the Hwy 87/Branham Lane area. Ms. Rodgers also voiced concern that this issue is becoming increasingly im-

portant to VEP area residents, and that hopefully it will become an increasingly important issue for collaboration between City Councilmembers and County Supervisors. Anyone running for San Jose City Mayor should anticipate questions regarding a plan for managing the issue of homelessness in San Jose.

The third guest speaker was Connie Corrales, Program Director for Sourcwise. She directs the Health Insurance Counseling and Advocacy Program. Ms. Corrales provided a very concise presentation on Medicare and resources available through Sourcwise. Each attendee received a packet of information and Ms. Corrales encouraged those with specific concerns or questions to contact Sourcwise to make an individual appointment. A counselor can provide information specific to your situation. If you are currently covered by Medicare, you do not need to be concerned about this new program. You are covered by Medicare and related insurance programs for Medicare covered individuals. Do not give out any personal information, particularly your Medicare number, to anyone over the phone. Be wary of fraud. Due to the visibility in the news regarding the new Affordable Care Act insurance availability, many scam artists are at work providing wrong information to Seniors. A second caution concerns Part D (prescription coverage) of Medicare. If you are currently covered by a managed care policy, Part D is already incorporated as part of your coverage. Do not change providers for Part D without first checking with your primary Senior Advantage/Medicare provider or before contacting Sourcwise to discuss your specific situation. If you do sign-up for a new separate Part D provider, you will disenroll yourself from your Senior Advantage program. To contact Sourcwise for more information or request a free counseling session, call 408/350-3200, option 1.

In the final presentation, TAPS Security Patrols provided brief information on security patrols in the VEP neighborhoods. TAPS has initiated private security patrols without requiring a —minimum number— of household signups prior to patrols beginning. However, in order for the service to continue into the future, additional households will need to signup for this service. Private security patrols provide additional visibility and security – a deterrent to crime. The patrols are made during the day and at night, seven days per week. Subscribers to the service also are provided vacation checks, package pickups, and —verification— of home security alarms (note – police no longer respond to —unverified— alarms at homes or businesses). This service is currently provided at a rate of \$17.50 per month. ## Crime and Safety in VEP Neighborhoods: Autumn and the Upcoming Holidays

Beginning in September 2012, VEP initiated a series of meetings and other opportunities for neighbors to come together to become better informed about the increase in crime and other safety issues, including: traffic, speeding, and vehicle accidents in our neighborhood. Many residents became actively engaged in informing themselves and their neighbors about many of these alarming issues.

As a result, our neighborhoods are becoming better equipped to initiate actions which keep our streets and homes both attractive and safe.

While much of this is positive, the fact remains that all of us need to continue to educate ourselves and continue to be vigilant! This is particularly true as Fall has arrived, with the change in daylight savings time returning to standard time – and darkness upon us by 5:15pm (and soon, even earlier)!

With daylight hours fading earlier in the day, those that walk or ride bicycles need to be especially aware. Particularly at dusk – danger increases as drivers in vehicles often have difficulty seeing you. Tips to be safe while walking include: having a flashlight with you - and periodically shining it on yourself, wear lighter clothing (popular dark clothing limits visibility), wear reflective tape on your clothing – legs or arms. Bicycle riders – equip your bikes with a headlight, reflectors on front and rear, on wheels, and on pedals. Also, wearing lighter clothing or reflective tape on clothing helps drivers see you in advance.

**Protecting Pets While Walking** – pets also need to be protected while on their daily walks. Use reflective vests and reflective leashes (or tape) on dogs, particularly if walking at dusk or after dark.

**Darkness - Increases Home and Vehicle Crimes** – lighting the exterior of homes/yards discourages criminal activity around your property – for both home and vehicles. Turn porch lights on, and encourage your neighbors to do the same. Be sure to report street/pole lights that have gone dark to the City. The City depends on residents to report dark street lights.

## Holiday Tree Curbside Pick-Up

Recycle your holiday tree on your regular collection day from December 26th throughout the entire month of January each year.

Natural and flocked holiday trees will be collected for recycling on the same day as your garbage, recycling, and yard trimmings. You don't need to attach an "Extra Garbage" sticker, but you do need to remove all tinsel, decorations, and the tree stand. Trees should then be cut into five-foot lengths and placed in the street. Be sure to keep the sections 1 foot from the curb and 5 feet away from your garbage and recycling carts, and any parked vehicles.

If you live in an apartment, townhouse, or condo, ask your property manager if special arrangements have been made for recycling holiday trees on-site.

## Narvaez Avenue (\*)

It may not have seemed much of a choice at the time, but in later years Jose Agustin Narvaez was never sorry he agreed in 1797 to become a colonist in California rather than go to jail in Mexico.

Although he spent only six years in Branciforte (Santa Cruz), choosing instead to become a soldier at the Presidio of San Francisco, the decision gave 17-year old Agustin a new start on a long life in which he was to hold public office, own thousands of acres of land, and raise a family of thirteen.

Agustin, according to his great-great-granddaughter, Mrs. Betty Skilling of Half Moon Bay, was —juvenile delinquent picked up on the streets of Guadalajara.” He was brought to California with several others who had run afoul of the law to become colonists in a new settlement to be called Branciforte.

In 1800 Agustin married Josefa Higuera and in 1803 he became a soldier and with his wife and infant son, moved to the Presidio up on the Bay.

By 1817 he was again a civilian and living in the Santa Clara Valley, possibly on the land he was later to receive in a grant from the Mexican government. The last five of his thirteen children were born here between 1817 and 1827, according to baptismal records Mrs. Skilling obtained from the old Mission at Santa Clara.

In 1821, a year before Mexico won independence from Spain, Agustin was serving as alcalde (mayor) at the pueblo of San Jose, Mrs. Skilling says, and in 1827 he was a councilman. This was the year his thirteenth child, Jose Dolores Narvaez, Mrs. Skiffing's great-grandfather, was born.

Agustin was 64 in 1844 when he received the 8,879-acre Rancho San Juan Bautista (so-named because he shared his birthday with St. John the Baptist) from Gov. Manuel Micheltorena.

On current maps the huge rancho, on which five adobe structures were built and where hundreds of cattle and horses grazed before the gringo came, would stretch roughly from Los Gatos Creek eastward to beyond —Signposts” marking Narvaez Avenue, north into Willow Glen and south to Blossom Hill Road.

Four different flags flew over California during his lifetime. The land belonged to Spain when the —Concepcion” sailed into Monterey Bay with the convict colonists on May 12, 1797. It was the Mexican flag that flew over San Jose when he received his grant of two square leagues. Later the banner was the crudely-drawn Bear Flag and then the Stars and Stripes of the United States.

Agustin was 83 when he received a government patent to Rancho San Juan Bautista, large parts of which had already been sold to immigrants who had come in weathered covered wagons, trading their gold pans for plows.

A painting of Jesus blessing St. John the Baptist was part of the shrine in the home when Agustin was alive, and each June on St. John the Baptist Day he dressed in his finest clothes, and mounted on his best horse draped with beautiful serapes took the painting on a pilgrimage to Mission Santa Clara.

After Mass, he rode the long miles back to the rancho to wind up his birthday among relatives whose names included some of the area's most prominent early California families...Ortegas, Chaboyas, Berryessas, Alvisos, Sepulvedas.

This painting, commissioned by Agustin 150 years ago, hangs in the de Saisset Art Gallery at the University of Santa Clara, the gift of Modesta Cantua, his daughter.

How did this happen? I tried so hard not to let it and yet somehow it did. After years of saying —I'll never do that!" and —I will never think like that!" I have to admit I HAVE done that and I HAVE thought like that. I have become my mother!

My mother and I have had our conflicts, and haven't always seen things in the same light. In the past I have blamed Mom for things I thought I missed out on in my growing up years, but have now realized she was doing what she and my father thought was best.

While raising my sons, I tried to pass down the things I found my mother did correctly (in my eyes), and eased up on subjects I didn't find important. I think most parents strive to do this, although we are not always successful.

Mom taught me to respect my elders, always be courteous to others, lend a hand or an ear when needed, share with others, and take pleasure in the little things. When it comes down to it, I am thankful for my upbringing and the influence of both my parents in my life.

My parents live out of state and I only see them once a year, but when I do Mom and I share her kitchen to bake something. She would approve of the following recipe:

### Cinnamon-Chip Scones

#### *Ingredients:*

2 ½ cups all-purpose flour  
1/3 cup sugar  
3 teaspoons baking powder  
1 teaspoon ground cinnamon, divided  
½ cup cold butter  
2/3 cup cinnamon baking chips  
1 cup plus 1 tablespoon heavy whipping cream, divided  
1 egg  
1 tablespoon coarse sugar.

#### *Instructions:*

In a large bowl, combine the flour, sugar, baking powder and ½ teaspoon cinnamon.

Cut in butter until mixture resembles coarse crumbs.

Stir in cinnamon chips.

Whisk 1 cup cream and egg; stir into crumb mixture just until moistened.

Turn dough onto a floured surface; knead 10 times.

Pat into a 9-inch circle. Cut into 12 wedges.

Separate wedges and place on a greased baking sheet.

Brush with remaining cream.

Combine coarse sugar, remaining cinnamon; sprinkle over tops.

Bake at 400 degrees for 14-16 minutes or until golden brown.

Serve warm.

## Planting and Caring for Hydrangeas

Hydrangeas are an attractive perennial that call for little care. Few insects or diseases affect hydrangeas. But planting hydrangeas requires some care. After you obtain a starter, dig a hole larger than the container it came in. Place the plant in a hole where it will get a northern exposure, ensuring that the crown of the plant is slightly above the level of the native soil. Backfill with a mix of soil with a lot of compost, using excess soil to build a watering basin. Fill the basin with water, checking to see that there is little or no settling of the plant.

Hydrangeas thrive on ample water. Feed the plant when it leafs out in the spring and every other month during the growing season. Use about one-quarter cup of sulfate of ammonia, and spread it in a wide circle under the hydrangea. Water-in afterward.

In hot spells, may show signs of wilting, only to recover when the sun goes down. This is a natural occurrence called "incipient wilting." It happens even if the soil is very wet.

### Hydrangea Care:

Hydrangeas bloom on the shoots produced in the previous year. Cut off the blossoms after the flowers have faded. Prune them just above the second set of buds from the bottom of the stem. The new shoots that grow from these buds will bloom in the following year. It is hard to kill a hydrangea.

After the plant is several years old, you may need to thin out the multitude of stems, removing any crossing, dead, or diseased stems. The older stems will be a darker color, with brown or gray scaly bark. These may no longer be productive and need to be pruned back to a set of buds near the base of the plant. New stems will emerge to replace the old.


